RESOLUTION NO. SP- **8755**, S-2021

A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO PURCHASE AUTOMATIC ALCOHOL DISPENSER WITH STAND AND NON-SLIP DISINFECTING FOOT MAT AND TRAY TO BE CHARGED AGAINST THE AVAILABLE FUNDS OF THE OFFICE OF THE CITY MAYOR FOR DISTRIBUTION TO THE VARIOUS BARANGAY HALLS, BARANGAY HEALTH CENTERS, ELEMENTARY AND HIGH SCHOOLS, MULTI-PURPOSE HALLS AND HOMEOWNERS ASSOCIATIONS OF THE 5TH LEGISLATIVE DISTRICT OF QUEZON CITY AND TO TRANSFER THE OWNERSHIP OF THE SAID EQUIPMENT TO THE RECIPIENTS WITHOUT COST.

WHEREAS, the Quezon City Government is committed in providing valuable basic services to the residents of Quezon City;

WHEREAS, the various barangay halls, barangay health centers, elementary and high schools, multi-purpose halls, and homeowner's associations in District VI, Quezon City are in need of automatic alcohol dispenser with stand and non-slip disinfecting foot mat to ensure the protection of barangay officials and staff, health workers, school officials, teachers and staff, HOA officials and staff, as well as all the other people undertaking official dealings with them, as a means of preventing the spread of COVID-19 and maintaining a safe environment while continuing their normal operations amidst the pandemic, with specifications as follow:

AUTOMATIC ALCOHOL DISPENSER WITH STAND

- Battery operated/ power operated
- Touchless hand disinfection system with automatic sensor
- Built-in bottle, has capacity of 1000ml
- Dimension, 5 inches x 10 inches
- Customized Steel Stand
- With Alkaline Battery type C, 4pcs/ pack
- With DC power adaptor

DISINFECTANT MAT AND TRAY

- Durable Plastic Tray with dimension, 39cm x 56cm
- With Chlorine solution 1kilo/ pack

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Mayor, as the Chief Executive of the Quezon City Government, shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance;

WHEREAS, a Deed of Donation will transfer the ownership to the beneficiaries, thereby authorizing them to appropriate funds from their respective budgets for the maintenance of the said equipment.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Quezon City Government, through the City Mayor, Honorable Ma. Josefina G. Belmonte, to purchase automatic alcohol dispenser with stand and non-slip disinfecting foot mat and tray to be charged against the available funds of the Office of the City Mayor for distribution to the various barangay halls, barangay health centers, elementary and high schools, multi-purpose halls and homeowners associations of the 6th Legislative District of Quezon City and to transfer the ownership of the said equipment to the recipients without cost.


