RESOLUTION NO. SP. 8758, S-2021

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ACCEPT THE DONATION FROM MEGAWIDE CONSTRUCTION CORPORATION AND TO SIGN THE RELATED DEED OF DONATION AND MEMORANDUM OF AGREEMENT EXECUTED BY THE DONOR FOR THE CONSTRUCTION OF A FIELD HOSPITAL IN LOTS C, D, AND E OF LOT 112-B-3, PAYATAS ROAD, BARANGAY PAYATAS, DISTRICT II, QUEZON CITY.

WHEREAS, on 8 March 2020 President Rodrigo Roa Duterte issued Proclamation No. 922 "Declaring a State of Public Health Emergency Throughout the Philippines" due to COVID-19 pandemic;

WHEREAS, on 13 March 2020, the Quezon City Council declared Quezon City to be under a state of calamity due to pandemic;

WHEREAS, it is the policy of the local government of Quezon City to extend partnership and cooperation with humanitarian organizations and private entities in addressing health issues which affect its constituents;

WHEREAS, the Quezon City Government has determined that there is a critical need to construct COVID-19 facilities in the city, such as but not limited to, quarantine facilities and field hospitals, to deliver health services to its constituents, particularly those who tested positive for COVID-19;

WHEREAS, the Quezon City Government, seeking to alleviate the plight of its constituents brought about by the COVID-19 pandemic, adopts measures to respond to the current health crisis, such as entering into an agreements with the private sectors and other stakeholders;

WHEREAS, to aid the Quezon City Government in its fight against COVID-19 and participate in the country's collective efforts against COVID-19, Megawide Construction Corporation manifested its intention to construct a field hospital in Lots C, D and E of Lot 112-B-3, Payatas Road, Barangay Payatas, Quezon City, a registered property under the name of the Quezon City Government, with a project cost amounting to Twelve Million Pesos (Php12,000,000.00) under the terms and conditions as may be mutually agreed upon by the parties;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to accept the donation from Megawide Construction Corporation and to sign the related Deed of Donation and Memorandum of Agreement executed by the donor for the construction of a field hospital in Lots C, D, and E of Lot 112-B-3, Payatas Road, Barangay Payatas, District II, Quezon City.
