RESOLUTION NO. SP- **8761**, S-2021

A RESOLUTION RENEWING THE SPECIAL PERMIT OF BINGO PALACE CORPORATION TO OPERATE AN ELECTRONIC BINGO (E-BINGO) AND TRADITIONAL BINGO AT LG/F CONGRESSIONAL TOWN CENTER, NO. 23 CONGRESSIONAL AVENUE, BARANGAY BAHAY TORO, DISTRICT I, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, Bingo Palace Corporation is a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with business address at LG/F Congressional Town Center, No. 23 Congressional Avenue, Barangay Bahay Toro, District I, Quezon City;

WHEREAS, Bingo Palace Corporation is primarily engaged in the business of Electronic Bingo (E-Bingo) and Traditional Bingo;

WHEREAS, to enable the applicant to operate an Electronic Bingo in Quezon City, there is a need to secure a Special Permit from the City Council pursuant to existing ordinance in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Bingo Palace Corporation is requesting the City Council to renew their Special Permit to operate an Electronic Bingo (E-Bingo) and Traditional Bingo.
