RESOLUTION NO. SP. 8764, S-2021

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PETRON CORPORATION (EAST AVENUE PETRON SERVICE CENTER CORP.) FOR THE CONSTRUCTION AND OPERATION OF A ONE (1)-STOREY GASOLINE STATION, ONE (1)-STOREY ADMINISTRATION BUILDING WITH SALES ROOM, STORAGE, OFFICE, LUBE BAY, ENGINE ROOM, TOILETS, ALR AND WASHBAY (AS BUILT) LOCATED AT LOT R.P. 3-B-3-A-1-A-2-B-5-I-8-A NIA ROAD CORNER EAST AVENUE, BARANGAY PINYAHAN, DISTRICT IV, QUEZON CITY.

WHEREAS, Petron Corporation (East Avenue Petron Service Center Corp.) is applying for a Special Use Permit for the construction and operation of a One (1)-Storey Gasoline Station, One (1)-Storey Administration Building with Sales Room, Storage, Office, Lube Bay, Engine Room, Toilets, ALR and Washbay (As Built) located at Lot R.P. 3-B-3-A-1-A-2-B-5-I-8-A NIA Road corner East Avenue, Barangay Pinyahan, District IV, Quezon City;

WHEREAS, pursuant to Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, an exception is required for the aforementioned project only upon authorization by the Quezon City Council;

WHEREAS, the Special Use Permit shall be subject to the following conditions, to wit: (a) the exception will not adversely affect public health, safety, and welfare, and is in keeping with the general pattern of development in the community; (b) the proposed project shall support economic-based activities and provide livelihood, vital community services and facilities and at the same time, pose no adverse effect on the zone or community; (c) the exception will not adversely affect the appropriate use of the adjoining property in the same district; and (d) the exception will not alter the essential character and general purpose of the district where the exception sought is located:

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Special Use Permit to Petron Corporation (East Avenue Petron Service Center Corp.) for the construction and operation of a One (1)-Storey Gasoline Station, One (1)-Storey Administration Building with Sales Room, Storage, Office, Lube Bay, Engine Room, Toilets, ALR and Washbay (As Built) located at Lot R.P. 3-B-3-A-1-A-2-B-5-I-8-A NIA Road corner East Avenue, Barangay Pinyahan, District IV, Quezon City.
