RESOLUTION NO. SP- **8765**, S-2021

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PETRON CORPORATION (RD GASOLINE STATION AND SERVICENTER GAS RETAILING) FOR THE CONSTRUCTION AND OPERATION OF A ONE (1)-STOREY GASOLINE STATION AND ONE (1)-STOREY ADMINISTRATION BUILDING WITH SALES ROOM, OFFICE, WASH/LUBE BAYS, STAFF QUARTERS, STORAGE, ENGINE ROOM, PARKING, AND PUBLIC TOILETS (AS BUILT) LOCATED AT LOTS 380-B-1 AND 567-C-1, NO. 145 TANDANG SORA AVENUE, BARANGAY TANDANG SORA, DISTRICT VI, QUEZON CITY.

WHEREAS, Petron Corporation (RD Gasoline Station and Servicenter Gas Retailing) is applying for a Special Use Permit for the construction and operation of a One (1)-Storey Gasoline Station and One (1)-Storey Administration Building with Sales Room, Office, Wash/Lube Bays, Staff Quarters, Storage, Engine Room, Parking, and Public Toilets (As Built) located at Lots 380-B-1 and 567-C-1, No. 145 Tandang Sora Avenue, Barangay Tandang Sora, District VI, Quezon City;

WHEREAS, pursuant to Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, an exception is required for the aforementioned project only upon authorization by the Quezon City Council;

WHEREAS, the Special Use Permit shall be subject to the following conditions, to wit: (a) the exception will not adversely affect the public health, safety and welfare, and is in keeping with the general pattern of development in the community; (b) the proposed project shall support economic-based activities and provide livelihood, vital community services and facilities and at the same time, pose no adverse effect on the zone or community; (c) the exception will not adversely affect the appropriate use of the adjoining property in the same district; and (d) the exception will not alter the essential character and general purpose of the district where the exception sought is located;
