RESOLUTION NO. SP. 8768, S-2021

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PETRON CORPORATION (MINDANAO AVENUE SERVICE CENTER) FOR THE CONSTRUCTION AND OPERATION OF A ONE (1)-STOREY GASOLINE STATION, ONE (1)-STOREY ADMINISTRATION BUILDING WITH SALES ROOM, STORAGE, OFFICE. TOILETS AND LUBE BAY AND TWO (2)-STOREY ENGINE ROOM WITH BOYS' QUARTERS AND WASH BAY (AS BUILT) LOCATED AT LOTS 11 AND 12, BLOCK N-28, NO. 57 MINDANAO AVENUE, BARANGAY BAGONG PAG-ASA, DISTRICT I, QUEZON CITY.

WHEREAS, Petron Corporation (Mindanao Avenue Service Center) is applying for a Special Use Permit for the construction and operation of a One (1)-Storey Gasoline Station, One (1)-Storey Administration Building with Sales Room, Storage, Office, Toilets and Lube Bay and Two (2)-Storey Engine Room with Boys' Quarters and Wash Bay (As Built) located at Lots 11 and 12, Block N-28, No. 57 Mindanao Avenue, Barangay Bagong Pag-Asa, District I, Quezon City;

WHEREAS, pursuant to Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, an exception is required for the aforementioned project only upon authorization by the Quezon City Council;

WHEREAS, the Special Use Permit shall be subject to the following conditions, to wit: (a) the exception wil! not adversely affect public health, safety, and welfare, and is in 'seping with the general pattern of development in the community; (b) the proposed project shall support economic-based activities and provide livelihood, vital community services and facilities and at the same time, pose no adverse effect on the zone or community; (c) the exception will not adversely affect the appropriate use of the adjoining property in the same district; and (d) the exception will not alter the essential character and general purpose of the district where the exception sought is located:
