RESOLUTION NO. SP- **8777**, S-2021

A RESOLUTION RATIFYING THE CONTRACTS OF AGREEMENT ENTERED INTO BY THE QUEZON CITY GOVERNMENT (QCG) AND THE WINNING BIDDERS AND/OR CONTRACTORS OF THE VARIOUS INFRASTRUCTURE PROJECTS (NEGOTIATED PROJECTS - WITH COVID-19 TRIAGE AREA, PROJECT NOS. 20-035N TO 20-042N; 20-050N TO 20-059N) SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.
