A RESOLUTION GRANTING A SPECIAL PERMIT TO LUCENT GAMING AND ENTERTAINMENT, OPC., REPRESENTED BY RICHELLE ROSE SA. LABRUSCA, TO OPERATE, CONDUCT GENERAL AND MAINTAIN THE BUSINESS OF SMALL TOWN LOTTERY (STL) IN THEIR BUSINESS ESTABLISHMENTS WITHIN THE TERRITORIAL JURISDICTION OF QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO).

WHEREAS, the Lucent Gaming and Entertainment, OPC., represented by Richelle Rose SA. Labrusca, is a duly registered association in the Philippines and with a principal office located at 101 Ground Floor, R&J Building, Quirino Highway, Sauyo, Novaliches, Quezon City, Metro Manila;

WHEREAS, Lucent Gaming and Entertainment, OPC., through Richelle Rose SA. Labrusca, is the appointed Authorized Agency Corporation (AAC) by the Philippine Charity Sweepstakes Office (PCSO) to operate the Small Town Lottery (STL) in Quezon City, Metro Manila;

WHEREAS, to enable the Lucent Gaming and Entertainment, OPC., through Richelle Rose SA. Labrusca, to operate, conduct general and maintain the business of Small Town Lottery (STL) within the territorial jurisdiction of Quezon City, there is a need to secure a Special Permit from the City Council pursuant to Ordinance No. SP-2285, S-2014, in relation to the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, Lucent Gaming and Entertainment, OPC., through Richelle Rose SA. Labrusca, is requesting the City Council to issue a Special Permit to operate, conduct general and maintain the business of Small Town Lottery (STL) within the territorial jurisdiction of Quezon City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, a Special Permit to Lucent Gaming and Entertainment, OPC., represented by Richelle Rose SA. Labrusca, to operate, conduct general and maintain the business of Small Town Lottery (STL) in their business establishments within the territorial jurisdiction of Quezon City, subject to the rules and regulations promulgated by the Philippine Charity Sweepstakes Office (PCSO).

RESOLVED FURTHER, that Lucent Gaming and Entertainment, OPC., through Richelle Rose SA. Labrusca, shall remit to the City Treasurer's Office a franchise fee of one percent (1%) of the gross revenue of herein grantee, which shall be made payable to the City Treasury during the lifetime of the measure.

RESOVED FURTHERMORE, that Lucent Gaming and Entertainment, OPC., under this Special Permit, shall only be managed and operated by Richelle Rose SA. Labrusca or her assignees.

RESOLVED FINALLY, that the authority herein granted shall be valid for a period of three (3) years and may be renewed by the City Council.
