A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO EXTEND FINANCIAL ASSISTANCE, IN BEHALF OF THE QUEZON CITY GOVERNMENT, IN THE AMOUNT OF TWO MILLION FIVE HUNDRED THOUSAND PESOS (PHP2,500,000.00) TO FUND THE PROJECTS AND ACTIVITIES OF THE QUEZON CITY LADIES FOUNDATION, INC. TO BE TAKEN FROM THE APPROPRIATION FOR GRANTS, AIDS AND SUBSIDIES UNDER THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to extend financial assistance, in behalf of the Quezon City Government, in the amount of Two Million Five Hundred Thousand Pesos (Php2,500,000.00) to fund the projects and activities of the Quezon City Ladies Foundation, Inc. to be taken from the appropriation for grants, aids and subsidies under the Office of the City Mayor or from any available funds.
