BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. (C40) and execute the related Deed of Donation and Acceptance for the establishment of the Quezon City Air Quality Monitoring Network.
