A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO MR. EDWIN CUA FOR THE CONSTRUCTION OF A THREE (3)-STOREY INDUSTRIAL BAKERY WITH RESIDENCE (AS BUILT) LOCATED AT NO. 39 MORATO AVENUE CORNER SUBIC STREET, BARANGAY DAMAYAN, DISTRICT I, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Mr. Edwin Cua is applying for the issuance of a Certificate of Exception for the construction of a Three (3)-Storey Industrial Bakery with Residence (As Built) located at No. 39 Morato Avenue corner Subic Street, Barangay Damayan, District I, Quezon City, in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;

WHEREAS, the applicant has submitted all the necessary and mandatory requirements in support of the proposed project and undertakes to comply with the provisions of existing laws, ordinances, rules and regulations pertaining to public safety, environmental protection, and vehicular traffic.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to Mr. Edwin Cua for the construction of a Three (3)-Storey Industrial Bakery with Residence (As Built) located at No. 39 Morato Avenue corner Subic Street, Barangay Damayan, District I, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
