RESOLUTION NO. SP- 8792, S-2021

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO JUNCTION JR. CORPORATION FOR THE CONSTRUCTION AND OPERATION OF A PETRON GASOLINE REFILLING STATION WITH LUBE SERVICE (AS BUILT) LOCATED AT LOT 18, BLOCK S-25 TOMAS MORATO AVENUE CORNER TIMOG AVENUE, BARANGAY LAGING HANDA, DISTRICT IV, QUEZON CITY.

Introduced by Councilor IVY L. LAGMAN.

WHEREAS, Junction Jr. Corporation is applying for the issuance of a Special Use Permit for the construction and operation of a Petron Gasoline Refilling Station with Lube Service (As Built) located at Tomas Morato Avenue corner Timog Avenue, Barangay Laging Handa, District IV, Quezon City;

WHEREAS, pursuant to Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, an exception is required for the aforementioned project only upon authorization by the Quezon City Council;

WHEREAS, the Special Use Permit shall be subject to the following conditions, to wit: (a) the exception will not adversely affect the public health, safety, and welfare, and is in keeping with the general pattern of development in the community; (b) the proposed project shall support economic-based activities and provide livelihood, vital community services and facilities and at the same time, pose no adverse effect on the zone or community; (c) the exception will no adversely affect the appropriate use of the adjoining property in the same district; and (d) the exception will not alter the essential character and general purpose of the district where the exception sought is located;

WHEREAS, the applicant has complied with all the documentary and mandatory requirements as provided under existing and applicable laws, rules, ordinances and issuances.
