A RESOLUTION AUTHORIZING THE QUEZON CITY GOVERNMENT, THROUGH THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A CONTRACT FOR THE CONSTRUCTION OF THE QUEZON CITY JAIL PERIMETER FENCE AND GUARD TOWER AT THE BUREAU OF JAIL MANAGEMENT AND PENOLOGY (BJMP) FACILITY IN BARANGAY PAYATAS, DISTRICT II, QUEZON CITY, SUBJECT TO REGULAR AUDITING AND ACCOUNTING RULES AND REGULATIONS.

WHEREAS, there is already an Advice of Allotment for the Quarter Ending June 30, 2021 approved by the City, under the Department of Engineering, which will be the source of funding for the said construction;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.


