RESOLUTION NO. SP-**8813**, S-2021

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO TRI-EXCEL MANUFACTURING CORPORATION FOR THE CONSTRUCTION OF A PROPOSED RENOVATION AND INSTALLATION OF ADDITIONAL ROOF TO EXISTING THREE (3)-STOREY INDUSTRIAL MANUFACTURING BUILDING LOCATED AT LOT 5, BLOCK 137, NO. 127 WEST RIVERSIDE STREET, BARANGAY SAN ANTONIO, DISTRICT I, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Tri-Excel Manufacturing Corporation is applying for the issuance of a Certificate of Exception for the construction of a Proposed Renovation and Installation of Additional Roof to Existing Three (3)-Storey Industrial Manufacturing Building located at Lot 5, Block 137, No. 127 West Riverside Street, Barangay San Antonio, District I, Quezon City, in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;

WHEREAS, pursuant to the provisions of the aforesaid zoning ordinance, the construction of the proposed project may be allowed only upon authorization by the City Council;

WHEREAS, the proposed project will not adversely affect public health, safety and welfare, and is in keeping with the general pattern of development in the community;

WHEREAS, the issuance of a Certificate of Exception is requested by the applicant for the purpose of complying with the zone classification of the proposed project;


WHEREAS, the Sangguniang Barangay concerned, as well as the homeowners or residents thereat, did not interpose any objection to the proposed project;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to Tri-Excel Manufacturing Corporation for the construction of a Proposed Renovation and Installation of Additional Roof to Existing Three (3)-Storey Industrial Manufacturing Building located at Lot 5, Block 137, No. 127 West Riverside Street, Barangay San Antonio, District I, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
