RESOLUTION NO. SP- **8814** , S-2021

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PETRON CORPORATION (R-SIX GAS STATION) FOR THE CONSTRUCTION AND OPERATION OF A ONE (1)-STOREY GASOLINE STATION, ONE (1)-STOREY ADMINISTRATION BUILDING WITH SALES ROOM, STORAGE, TOILET AND LUBE BAY, AND ONE (1)-STOREY STORAGE WITH ENGINE ROOM AND TOILETS (AS BUILT) LOCATED AT LOTS 220-A AND 200-B, NO. 629 QUIRINO AVENUE, BARANGAY BAGBAG, NOVALICHES, DISTRICT V, QUEZON CITY.

WHEREAS, Petron Corporation (R-SIX Gas Station) is applying for the issuance of a Special Use Permit for the construction and operation of a One (1)-Storey Gasoline Station, One (1)-Storey Administration Building with Sales Room, Storage, Toilet and Lube Bay, and One (1)-Storey Storage with Engine Room and Toilets (As Built) located at Lots 220-A and 200-B, No. 629 Quirino Avenue, Barangay Bagbag, Novaliches, District V, Quezon City;

WHEREAS, pursuant to Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, a Special Use Permit is required for the aforementioned project upon authorization of the Quezon City Council;

WHEREAS, the Special Use Permit shall be subject to the following conditions, to wit: (a) the exception will not adversely affect the public health, safety and welfare, and is in keeping with the general pattern of development in the community; (b) the proposed project shall support economic-based activities and provide livelihood, vital community services and facilities and at the same time, pose no adverse effect on the zone or community; (c) the exception will not adversely affect the appropriate use of the adjoining property in the same district; and (d) the exception will not alter the essential character and general purpose of the district where the exception sought is located;

WHEREAS, the applicant has complied with all the documentary and mandatory requirements as provided under existing and applicable laws, rules, ordinances and issuances.
