RESOLUTION NO. SP- **8815** , S-2021

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO BSM HOLDING, INC. (ABENSON VENTURES, INC.) FOR THE CONSTRUCTION OF A PROPOSED ADDITIONAL BASEMENT, MEZZANINE AND BRIDGELINK AT 6TH FLOOR TO EXISTING TWELVE (12)-STOREY OFFICE BUILDING AT LOT 9, BLOCK B-3, DANGAY STREET CORNER LANUTAN STREETS, BARANGAY VETERANS VILLAGE, DISTRICT I, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, BSM Holding, Inc. (Abenson Ventures, Inc.) is applying for the issuance of a Certificate of Exception for the construction of a Proposed Additional Basement, Mezzanine and Bridgeline at 6th Floor to existing Twelve (12)-Storey Office Building located at Lot 9, Block B-3, Dangay Street corner Lanutan Streets, Barangay Veterans Village, District I, Quezon City, in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;

WHEREAS, pursuant to the provisions of the aforesaid zoning ordinance, the construction of the proposed project may be allowed only upon authorization by the Quezon City Council;

WHEREAS, the applicant has submitted the necessary and mandatory requirements in support of the proposed project and undertakes to comply with the provisions of existing laws, ordinances, rules and regulations pertaining to public safety, environmental protection, and vehicular traffic.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to BSM Holding, Inc. (Abenson Ventures, Inc.) for the construction of a proposed additional basement, mezzanine and bridgeline at 6th Floor to existing Twelve (12)-Storey Office Building located at Lot 9, Block B-3, Dangay Street corner Lanutan Streets, Barangay Veterans Village, District I, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
