RESOLUTION NO. SP-8819, S-2021

A RESOLUTION RENEWING THE SPECIAL PERMIT OF SOPISANTI GAMING CORPORATION TO OPERATE AN ELECTRONIC BINGO GAMES AT THE GROUND FLOOR, BAESA TOWN CENTER, BARANGAY BAESA, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

Introduced by Councilors IMEE A. RILLO and PEACHY V. DE LEON.

WHEREAS, Sopisanti Gaming Corporation, a domestic corporation duly organized and existing under and by virtue of Philippine laws, represented by Mr. Juanito Rommel Gracilla Finianos, is applying for a Special Use Permit to operate an electronic bingo games at the Ground Floor, Baesa Town Center, Barangay Baesa, Quezon City;

WHEREAS, the applicant was previously granted a Special Permit by the City Council for the operation of the same business;

WHEREAS, to enable the applicant to continue its business operations, there is a need to renew their Special Permit pursuant to an existing city ordinance;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing city ordinances, authorizes the City Council to grant or renew a special permit to business activity of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Sopisanti Gaming Corporation to operate an electronic bingo games at the Ground Floor, Baesa Town Center, Barangay Baesa, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an electronic bingo games granted herein shall be subject to the following conditions:

- a. The holding of electronic bingo games shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of electronic bingo games shall not include the playing of games not related to or other than e-bingo;
- c. The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing in the abovementioned games.

RESOLVED FINALLY, that this renewal of Special Permit to operate an Electronic Bingo Games shall be valid for a period of two (2) years from the approval of this Resolution and may be renewed again by the City Council.
