RESOLUTION NO. SP-8823, S-2022

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO DONATE BIODIGESTER SYSTEM UNITS TO THE DIFFERENT BARANGAYS IN QUEZON CITY TO BE UTILIZED FOR THE DEVELOPMENT OF SUSTAINABLE URBAN FARM.

WHEREAS, the Quezon City Government is in possession of four (4) Biodigester Systems which were purchased by the City Government by way of Public Bidding in the amount of One Hundred Ninety-Eight Thousand Pesos (Php198,000.00) per unit;

WHEREAS, said equipment were procured in consideration of developing sustainable urban farms across the City wherein organic wastes will be converted by the biodigesters into compost or soil conditioner;

WHEREAS, this initiative is in line with the priority programs of the City's Enhanced Local Climate Change Action Plan for 2021-2050 wherein Food Security is one of its pillars;

WHEREAS, the Quezon City Government is also a signatory to the C40 Good Food Declaration wherein one of its commitments is to support an overall increase of healthy-plant-based food consumption in our city as well as reduce the volume of food waste generated and disposed;

WHEREAS, the procured biodigester system has the following specifications (inclusive of set-up and installation):

- 1000 liters IBC Water Tank Drum with capacity to digest 25 kilos of biodegradable wastes per day
- Capable to produce 1 to 2 hours of cooking gas
- Complete with gas stove and safety gadgets
- 1 horse power shredder with capacity of 50 kilos of waste per hour
- Electric powered

WHEREAS, biodigester systems will be distributed to the following barangays/urban farms, to wit:

- 1. KruNali Farm Barangay Krus na Ligas
- 2. Sharon Farm Barangay Novaliches Proper
- 3. Greenland Farm Barangay Bagong Silangan
- 4. Sunnyville Farm Barangay Tandang Sora

WHEREAS, the Quezon City Government will be monitoring the use and output of the said equipment for purposes of recording the volume of organic waste diverted;

WHEREAS, the concerned barangays are agreeable to give its utmost care to the donated equipment and will be fully responsible of its upkeep;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.
