RESOLUTION NO. SP-**8838**, S-2022

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO RODRIGO C. SARCENO, FOR THE CONSTRUCTION OF A THREE (3)-UNIT/TWO (2)-STOREY RESIDENTIAL BUILDING (AS BUILT) LOCATED AT LOT 10, BLOCK 1, NO. 19 RUBY STREET, RAMER SUBDIVISION, MINDANAO AVENUE, BARANGAY TANDANG SORA, DISTRICT VI, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Rodrigo C. Sarceno is applying for the issuance of a Certificate of Exception for the construction of a Three (3)-Unit/Two (2)-Storey Residential Building (As Built) located at Lot 10, Block 1, No. 19 Ruby Street, Ramer Subdivision, Mindanao Avenue, Barangay Tandang Sora, District VI, Quezon City, in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;

WHEREAS, pursuant to the provisions of the aforesaid zoning ordinance, the construction of the proposed project may be allowed only upon authorization by the Quezon City Council;

WHEREAS, the proposed project will not adversely affect public health, safety and welfare, and is in keeping with the general pattern of development in the community;

WHEREAS, the request for exemption is for the purpose of complying with the density requirements provided by the Zoning Ordinance;

WHEREAS, the Sangguniang Barangay concerned, as well as the homeowners or residents thereat, did not interpose any objection to the proposed project;



Sarceno, for the construction of a Three-(3) Unit/Two (2)-Storey Residential Building (As Built) located at Lot 10, Block 1, No. 19 Ruby Street, Ramer Subdivision, Mindanao Avenue, Barangay Tandang Sora, District VI, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.


