A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PRIVATE AND PUBLIC INSTITUTIONS FOR THE ESTABLISHMENT OF VACCINATION SITES FOR THE INOCULATION OF RESIDENTS AND WORKERS IN QUEZON CITY.

WHEREAS, on 8 March 2020, President Rodrigo Roa Duterte issued Proclamation No. 922 "Declaring a State of Public Health Emergency Throughout the Philippines" due to COVID-19 pandemic; S

WHEREAS, on 13 March 2020, the Quezon City Council declared Quezon City to be under a State of Calamity due to pandemic; b

WHEREAS, it is the policy of the local government of Quezon City to extend partnership and cooperation with humanitarian organizations and private entities in addressing health issues which affect its constituents;

WHEREAS, the Quezon City Government is committed to collaborate with various stakeholders in its efforts to prevent, mitigate, and contain the spread of COVID-19 within its territorial jurisdiction;

WHEREAS, to quickly inoculate as many individuals as possible, the City Government seeks for volunteers from the private and public institutions to add manpower to the City's vaccination sites;

WHEREAS, in consideration of the private and public institution's contribution in providing for venue and volunteers, the City Government shall inoculate with COVID-19 vaccines the qualified personnel of the private and public institutions with the assistance of the medical workers and other volunteers under the supervision of the representatives from the City Government;

WHEREAS, the Quezon City Council has enacted Ordinance No. SP-3048, S-2021 entitled "An Ordinance Regulating COVID -19 Vaccination Sites and Programs in Quezon City";

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with the private and public institutions for the establishment of vaccination sites for the inoculation of residents and workers in Quezon City.


