WHEREAS, pursuant to Section 455 (b)(1)(v) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Local Chief Executive, acting as the Appointing Authority, shall "Appoint all officials and employees whose salaries and wages are wholly or mainly paid out of city funds and whose appointments are not otherwise provided for in this Code, as well as those he may be authorized by law to appoint";

WHEREAS, the City Mayor, Honorable Ma. Josefina G. Belmonte, has appointed Atty. Mark Dale Diamond P. Perral as City Government Department Head III (SG-27) - (1<sup>st</sup> Step) under the permanent status at the Department of Engineering;

WHEREAS, Section 454 (d) of the Local Government Code of 1991 requires that appointments of heads of department and offices issued by the City Mayor shall be with the concurrence of the City Council;
