A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH DON JOSE HEIGHTS HOMEOWNERS ASSOCIATION, INC., FOR THE USE, MANAGEMENT AND MAINTENANCE OF THE IMPROVEMENT WITHIN THE OPEN SPACE OF THE SAID SUBDIVISION.

WHEREAS, the Quezon City Government is the donee of a parcel of land classified as an open space within the Don Jose Heights Subdivision donated to the Quezon City Government on 19 June 1970 by Donor, Mr. Jose E. Desiderio, Sr./Country Bankers Life Insurance Corporation;

WHEREAS, the Department of Public Works and Highways (DPWH) will implement the construction of an Al Fresco Sky Roof (approximately 225 square meters) and an Administrative Office/Board Room (approximately 150 square meters) within the open space of the subdivision;

WHEREAS, Don Jose Heights Homeowners Association, Inc. wishes to use, manage, and maintain the improvement of said open space for the benefit of its members and the community in general;

WHEREAS, Don Jose Heights Homeowners Association, Inc., in the exercise of its right to use the improvement, shall maintain and preserve the same in good condition and shall shoulder all the expenses necessary for the use, management, maintenance, and preservation of the same;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with Don Jose Heights Homeowners Association, Inc., for the use, management and maintenance of the improvement within the open space of the said subdivision.

RESOLVED FURTHER, that a copy of the subject Memorandum of Agreement shall form an integral part of this Resolution.
