RESOLUTION NO. SP. 8881 . S-2022

A RESOLUTION AUTHORIZING THE LISUANCE OF A SPECIAL USE PERMIT TO UNIOIL PETROLEUM PHILIPPINES, INC. FOR THE CONSTRUCTION AND OPERATION OF A PROPOSED ONE (1)-STOREY GASOLINE STATION AND TWO (2)-STOREY STATION BUILDING WITH OFFICE, PUBLIC TOILETS FOR PERSONS WITH DISABILITIES (PWD), URINAL AREA, LOCKER ROOM WITH TOILET, ELECTRICAL ROOM AND PLUMBING UTILITIES LOCATED AT LOTS 13-A, 13-B-1 AND 14, BLOCK 32, EDSA, BARANGAY E. RODRIGUEZ SR., DISTRICT III, QUEZON CITY-

WHEREAS, Unicil Petroleum Philippines, Inc. is applying for the issuance of a Special Use Permit for the construction and operation of a proposed One (1)-Storey Gasoline Station and Two (2)-Storey Station Building with Office, Public Toilets for PWD, Urinal Area, Locker Room with Toilet, Electrical Room and Plumbing Utilities located at Lots 13-A, 13-B-1 and 14, Block 32, EDSA, Barangay E. Rodriguez, Sr., District III, Quezon City;

WHEREAS, pursuant to Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, an exception is required for the aforementioned project only upon authorization by the Quezon City Council;

WHEREAS, the Special Use Permit shall be subject to the following conditions, to wit: (a) the exception will not adversely affect the public health, safety and welfare, and is in keeping with the general pattern of development in the community; (b) the proposed project shall support economic-based activities and provide livelihood, vital community services and facilities and at the same time, pose no adverse effect on the zone or community; (c) the exception will not adversely affect the appropriate use of the adjoining property in the same district; and (d) the exception will not alter the essential character and general purpose of the district where the exception sought is located:

Rodriguez Sr., District III, Quezon City.
