A RESOLUTION RATIFYING THE CONTRACTS ENTERED INTO BY THE CITY, AS REPRESENTED BY THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, WITH THE WINNING BIDDERS FOR THE SOLID WASTE CLEAN-UP, COLLECTION AND DISPOSAL 2022-2023 PROJECT FOR THE SIX (6) DISTRICTS OF QUEZON CITY.

*WHEREAS, the Bids and Awards Committee conducted a bidding for the solid waste collection, clean-up and disposal 2022-2023 project on February 21, 2022;*

*WHEREAS, the contracts for solid waste collection, clean-up and disposal 2022-2023 project were signed and entered into by the City Mayor, Honorable Ma. Josefina G. Belmonte;*

*WHEREAS, garbage collection and disposal continues to be the perennial problem not only by the City, but by the entire country as a whole;*

*WHEREAS, the city is expressly mandated by the Local Government Code to deliver basic services related to general hygiene and sanitation to its residents;*

WHEREAS, there was no authority from the Quezon City Council when the contracts were signed, therefore, this ratification is necessary.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to ratify, as it does hereby ratify, the contracts entered into by the city, as represented by the City Mayor, Honorable Ma. Josefina G. Belmonte, with the winning bidders for the solid waste clean-up, collection and disposal 2022-2023 project, under the terms and conditions laid down by the pertinent contracts, ordinances and laws, as far as practicable and applicable, the Contract of Service with the following Service Providers:

District I - International Solid Waste Integrated Management Specialist, Inc. in venture with D.C Sandil Construction and Realty Development with a contract price of Three Hundred Twenty-Six Million Nine Hundred Forty-Six Thousand Eight Hundred Fifty-Two Pesos (Php326,946,852.00), inclusive of the 12% VAT.

District II - International Solid Waste Integrated Management Specialist, Inc. in venture with ISWIMS Transport Hauling Services, Inc. with a contract price of Two Hundred Forty-Three Million Nine Hundred Thirty-Three Thousand Four Hundred Twelve Pesos and Eighty Centavos (Php243,933,412.80), inclusive of VAT.

District III - International Solid Waste Integrated Management Specialist, Inc. in venture with Persan Construction with a contract price of Two Hundred Sixty-Nine Million Nine Hundred Sixty-Five Thousand Seventy-Eight Pesos and Sixty-Four Centavos (Php269,965,078.64), inclusive of 12% VAT.

District IV - International Solid Waste Integrated Management Specialist, Inc. in venture with Persan Construction with a contract price of Three Hundred Ninety-Seven Million One Hundred Seventy Thousand Three Hundred Seventy-Five Pesos (Php397,170,375.00), inclusive of VAT.

District V - International Solid Waste Integrated Management Specialist Inc. in venture with ISWIMS Transport Hauling Services, Inc. with a contract price of Two Hundred Sixty-Two Million Eight Hundred Eighty-Five Thousand Three Hundred Two Pesos and Twelve Centavos (Php262,885,302.12), inclusive of the 12% VAT.

*District VI - International Solid Waste Integrated Management Specialist, Inc. in venture with D.C Sandil Construction and Realty Development with a contract price of Two Hundred Ninety-Three Million One Hundred Ninety-Eight Thousand Nine Hundred Sixty-Five Pesos and Twenty Centavos (Php293,198,965.20).*
