RESOLUTION NO. SP- **8902**, S-2022

A RESOLUTION RENEWING THE SPECIAL PERMIT OF MILLENIUM BINGO FUN GAMING CORPORATION TO OPERATE AN ELECTRONIC BINGO GAMES (E-GAMES) LOCATED AT THE 2<sup>ND</sup> FLOOR, PEARL DRIVE COMPLEX, DON MARIANO FAIRVIEW, DISTRICT V, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, Millenium Bingo Fun Gaming Corporation is a corporation formed and registered under Philippine laws located at the 2<sup>nd</sup> Floor, Pearl Drive Complex, Don Mariano Fairview, District V, Quezon City, and is applying for the renewal of its Special Permit to operate an Electronic Bingo Games (E-Games);

WHEREAS, sometime in 2022, the City Council passed a Resolution granting a Special Permit to the applicant to operate the said Electronic Bingo Games (E-Games) docketed as Resolution No. SP-8194, S-2020;

WHEREAS, to enable Millenium Bingo Fun Gaming Corporation to continue its legal business operation, there is a need to renew the said Special Permit;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing City Ordinances, authorizes the City Council to grant Special Permit to business activity of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to renew, as it does hereby renew, the Special Permit of Millenium Bingo Fun Gaming Corporation to operate an Electronic Bingo Games (E-Games) located at the 2<sup>nd</sup> Floor, Pearl Drive Complex, Don Mariano Fairview, District V, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to operate an Electronic Bingo Games (E-Games) granted herein shall be subject to the following conditions:

- a. The holding of Electronic Bingo/ Games shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of Electronic Bingo Games shall not include the playing of games not related to or other than Electronic Games; and
- c. The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing in the abovementioned.


RESOLVED FURTHERMORE, that Millenium Bingo Fun Gaming Corporation shall remit to the City Treasurer's Office a franchise fee of three percent (3%) of the gross revenue of herein grantee, which shall be made payable yearly to the City Treasury during the lifetime of this measure.

RESOLVED FINALLY, that this Special Permit to operate an Electronic Bingo Games (E-Games) shall be valid for a period of two (2) years and may be renewed by the City Council.


