RESOLUTION NO. SP- **8903**, S-2022

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO DELUNA BROTHERS CONSTRUCTION CORPORATION FOR THE CONSTRUCTION OF A FOUR (4)-STOREY COMMERCIAL AND BOARDING HOUSE BUILDING (AS BUILT) LOCATED AT NO. 47 CAMARO STREET, WEST FAIRVIEW, DISTRICT V, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Four Brothers Construction Corporation, represented by Mr. Lorenzo De Luna Jr., co-owner, is applying for the issuance of a Certificate of Exception for the construction of a Four (4)-Storey Commercial and Boarding House Building (As Built) located at No. 47 Camaro Street, West Fairview, District V, Quezon City;

WHEREAS, pursuant to the provisions of the aforesaid zoning ordinance, the construction of the proposed project may be allowed only upon authorization by the Quezon City Council;

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to Deluna Brothers Construction Corporation for the construction of a Four (4)-Storey Commercial and Boarding House Building (As Built) located at No. 47 Camaro Street, West Fairview, District V, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
