WHEREAS, Ascension Phildevelopers, Inc., represented by Mr. Renato S. Dychangco, Jr., is applying for the issuance of a Special Use Permit for the operation of a Funeral Parlor with Mortuary Chapel, Columbaium and Crematorium at Lots 9 and 10, Block 573, No. 332 G. Araneta Avenue, Barangay Doña Imelda, District IV, Quezon City;

WHEREAS, the said funeral parlor, which is presently located in Major Commercial Zone (C-2), is already operational (formerly known as Nacional Memorial Homes) but with the assumption of a new owner/management it added the services of mortuary chapel, columbarium and crematorium;

WHEREAS, pursuant to the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, the issuance of a Special Use Permit is required for the operation of a funeral parlor, columbarium, and crematorium;

WHEREAS, the applicant has complied with all the necessary and mandatory requirements provided by the said Zoning Ordinance and undertakes not to use public roads adjacent to the building as parking space or alternative thereto.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Special Use Permit to Ascension Phildevelopers, Inc. for the operation of a Funeral Parlor with Mortuary Chapel, Columbarium and Crematorium at Lots 9 and 10, Block 573, No. 332 G. Araneta Avenue, Barangay Doña Imelda, District IV, Quezon City.
