WHEREAS, Nora San Pablo Bordeos is applying for the issuance of a Special Use Permit to be used for the construction and operation of a gasoline refilling station located at Lot 6, Block O-1, Katipunan Avenue, Barangay Milagrosa, District III, Quezon City;

WHEREAS, in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Quezon City Zoning Ordinance of 2016, a Special Use Permit shall be required for the construction and operation of a gasoline refilling station, subject to the authorization by the City Council through a Resolution;
