A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO MARILYN LIBUNAO DE LEON (PILIPINAS SHELL PETROLEUM CORPORATION) FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE REFILLING STATION LOCATED AT NO. 372 QUIRINO AVENUE CORNER TANDANG SORA AVENUE, BARANGAY TALIPAPA, DISTRICT VI, QUEZON CITY.

WHEREAS, Marilyn Libunao De Leon is applying for the issuance of a Special Use Permit to be used for the construction and operation of a gasoline refilling station located at No. 372 Quirino Avenue corner Tandang Sora Avenue, Barangay Talipapa, District VI, Quezon City;

WHEREAS, in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, a Special Use Permit shall be required for the construction and operation of a gasoline refilling station, subject to the authorization by the City Council through a Resolution;

WHEREAS, the members of the Sangguniang Barangay concerned and the residents nearby the place of business did not interpose any objection to the construction and operation of the said business establishment;

WHEREAS, the construction and operation of a gasoline refilling station in the area will not adversely affect the public welfare, but instead generate employment opportunity and promote the development of the city's economy.
