RESOLUTION NO. SP. 8922, S-2022

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO UNIOIL PETROLEUM PHILIPPINES - NTI PEARL DRIVE COMMONWEALTH FOR THE CONSTRUCTION AND OPERATION OF A PROPOSED TWO (2)-STOREY GASOLINE STATION AND ADMINISTRATION BUILDING WITH OFFICE, PUBLIC TOILETS, LOCKER ROOM WITH TOILET, ELECTRICAL ROOM AND URINAL AREA LOCATED AT LOT 2-B, DON MARIANO MARCOS AVENUE CORNER PEARL DRIVE, BARANGAY NOVALICHES PROPER, DISTRICT V, QUEZON CITY.

WHEREAS, Unioil Petroleum Philippines - NTI Pearl Drive Commonwealth is applying for the issuance of a Special Use Permit for the construction and operation of a proposed Two (2)-Storey Gasoline Station and Administration Building with Office, Public Toilets, Locker Room with Toilet, Electrical Room and Urinal Area located at Lot 2-B, Don Mariano Marcos Avenue corner Pearl Drive, Barangay Novaliches Proper, District V, Quezon City;

WHEREAS, pursuant to Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, and its Implementing Rules and Regulations, an exception is required for the aforementioned project upon authorization of the Quezon City Council;

WHEREAS, the Special Use Permit shall be subject to the following conditions, to wit: (a) the exception will not adversely affect the public health, safety and welfare, and is in keeping with the general pattern of development in the community; (b) the proposed project shall support economic-based activities and provide livelihood, vital community services and facilities and at the same time, pose no adverse effect on the zone or community; (c) the exception will not adversely affect the appropriate use of the adjoining property in the same district; and (d) the exception will not alter the essential character and general purpose of the district where the exception sought is located;
