RESOLUTION NO. SP-8926, S-2022

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO BICOL ISAROG TRANSPORT SYSTEM, INC. FOR THE OPERATION OF A ONE (1)-STOREY BUS TERMINAL GASOLINE STATION LOCATED AT LOTS 7-B AND 11, BLOCK 49, NO. 599 EDSA, BARANGAY SAN MARTIN DE PORRES, DISTRICT IV, QUEZON CITY.

WHEREAS, Bicol Isarog Transport System, Inc. is applying for the issuance of a Special Use Permit for the operation of a One (1)-Storey Bus Terminal Gasoline Station located at Lots 7-B and 11, Block 49, No. 599 EDSA, Barangay San Martin De Porres, District IV, Quezon City;

WHEREAS, pursuant to Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, an exception is required for the aforementioned project only upon authorization by the Quezon City Council;

WHEREAS, the Special Use Permit shall be subject to the following conditions, to wit: (a) the exception will not adversely affect the public health, safety and welfare, and is in keeping with the general pattern of development in the community; (b) the proposed project shall support economic-based activities and provide livelihood, vital community services and facilities and at the same time, pose no adverse effect on the zone or community; (c) the exception will not adversely affect the appropriate use of the adjoining property in the same district; and (d) the exception will not alter the essential character and general purpose of the district where the exception sought is located;

WHEREAS, the Sangguniang Barangay concerned, as well as the homeowners or residents thereat, did not interpose any objection to the proposed project;
