RESOLUTION NO. SP-8935, S-2022

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO SPI LAND DEVELOPMENT, INC. FOR THE CONSTRUCTION OF A PROPOSED TWO (2) RESIDENTIAL TOWERS AT SEVENTY-NINE (79)-STOREY EACH REACHING THREE HUNDRED (300) METERS AND VARIANCES PERTAINING TO FIREWALLS, SETBACKS, TERRACES AND BALCONY WITH PARKING, UTILITIES AND ROOF DECK TO BE LOCATED AT LOTS 3, 7 AND 8, BLOCK S-9, SGT. ESGUERRA STREET, BARANGAY SOUTH TRIANGLE, DISTRICT IV, *QUEZON* CITY, ALLOWING DEVIATION **FROM** RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, SPI Land Development, Inc. is applying for the issuance of a Certificate of Exception for the construction of a proposed Two (2) Residential Towers at Seventy-Nine (79)-Storey each reaching three hundred (300) meters and variances pertaining to Firewalls, Setbacks, Terraces and Balcony with Parking, Utilities and Roof Deck to be located at Lots 3, 7 and 8, Block S-9, Sgt. Esguerra Street, Barangay South Triangle, District IV, Quezon City, in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;

WHEREAS, pursuant to the provisions of the aforesaid zoning ordinance, the construction of the proposed project may be allowed only upon authorization by the Quezon City Council;

WHEREAS, the proposed project will not adversely affect public health, safety and welfare, and is in keeping with the general pattern of development in the community;

WHEREAS, the Sangguniang Barangay concerned, as well as the homeowners or residents thereat, did not interpose any objection to the proposed project;

Esguerra Street, Barangay South Triangle, District IV, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
