RESOLUTION NO. SP-**8940**, S-2022

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO HAVEN'S FUNERAL PARLOR FOR THE CONSTRUCTION AND OPERATION OF A ONE (1)-STOREY FUNERAL PARLOR BUILDING WITH CHAPEL, OFFICE, TOILET, BATHROOM AND STORAGE ROOM LOCATED AT LOT 49-B-8, (NO. 66) 5 MG COMPOUND, GROUP 1, PAYATAS ROAD CORNER GOLDEN SHOWER STREET, AREA-B, BARANGAY PAYATAS, DISTRICT II, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Haven's Funeral Parlor is applying for the issuance of a Special Use Permit for the construction and operation of a One (1)-Storey Funeral Parlor Building with Chapel, Office, Toilet, Bathroom and Storage Room located at Lot 49-B-8, (No. 66) 5 MG Compound, Group 1, Payatas Road corner Golden Shower Street, Area-B, Barangay Payatas, District II, Quezon City;

WHEREAS, pursuant to Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016, a Special Use Permit is required for the aforementioned project only upon authorization by the Quezon City Council;

WHEREAS, the proposed project will not adversely affect the public health, safety and welfare, and is in keeping with the general pattern of development in the community;

WHEREAS, the applicant has complied with all the mandatory and documentary requirements as provided under the existing and applicable ordinances, rules and regulations.
