*WHEREAS, Rosario B. Antonio is applying for the issuance of a Special Use Permit to be used for the construction and operation of a gasoline refilling station located at Lots 1 and 2-A, Block 1, E. Rodriguez Jr. Avenue, Barangay Bagumbayan, District III, Quezon City;*

*WHEREAS, in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Quezon City Zoning Ordinance of 2016, a Special Use Permit shall be required for the construction and operation of a gasoline refilling station, subject to the authorization by the City Council through a Resolution;*

*WHEREAS, the members of the Sangguniang Barangay concerned and the residents nearby the place of business did not interpose any objection to the construction and operation of the said business establishment;*


