RESOLUTION NO. SP- **8943**, S-2022

A RESOLUTION GRANTING A SPECIAL PERMIT TO VBROS TECHNOLOGY CORPORATION/UNIPROM, INC. TO CONDUCT A TRADITIONAL COCKFIGHTING KNOWN AS "THE 2022 WORLD SLASHER CUP INVITATIONAL 9-COCK DERBY" ON MARCH 21-24, 27 AND 28, 2022 AT SMART ARANETA COLISEUM, GENERAL ROXAS AVENUE, CUBAO, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR).

WHEREAS, VBros Technology Corporation/Uniprom, Inc., both domestic corporations duly organized and existing under and by virtue of Philippine laws, is applying for a Special Permit to conduct a traditional cockfighting known as "The 2022 World Slasher Cup Invitational 9-Cock Derby" on March 21-24, 27 and 28, 2022 at Smart Araneta Coliseum, General Roxas Avenue, Cubao, Quezon City;

WHEREAS, to enable the applicant to conduct the aforesaid Derby, there is a need to secure a Special Permit from the City Council pursuant to an existing city ordinance;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, in relation to existing city ordinances, authorizes the City Council to grant special permit to business activity of the same nature.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant, a Special Permit to VBros Technology Corporation/Uniprom, Inc. to conduct a traditional cockfighting known as "The 2022 World Slasher Cup Invitational 9-Cock Derby" on March 21-24, 27 and 28, 2022 at Smart Araneta Coliseum, General Roxas Avenue, Cubao, Quezon City, subject to the rules and regulations promulgated by the Philippine Amusement and Gaming Corporation (PAGCOR).

RESOLVED FURTHER, that the authority to conduct traditional cockfighting/9-Cock Derby granted herein shall be subject to the following conditions:


- a. The holding of Derby shall be in accordance with the Rules and Regulations promulgated by PAGCOR;
- b. The operation of Derby shall not include the playing of games not related to or other than Derby; and
- c. The operator is enjoined to prohibit individuals below eighteen (18) years of age from playing in the abovementioned games.

RESOLVED FINALLY, that this Special Permit to conduct a traditional cockfighting known as "The 2022 World Slasher Cup Invitational 9-Cock Derby" shall be valid from March 21-24, 27 and 28, 2022.


