WHEREAS, pursuant to Section 455 (b)(1)(v) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Local Chief Executive, acting as Appointing Authority, shall "Appoint all officials and employees whose salaries and wages are wholly or mainly paid out of city funds and whose appointments are not otherwise provided for in this Code, as well as those he may be authorized by law to appoint";

WHEREAS, the City Mayor, Honorable Ma. Josefina G. Belmonte, has appointed Eddilyn De Chavez Dividina as City Government Department Head III (SG-27) - (1st STEP) under the permanent status at the Quezon City Youth Development Department;

WHEREAS, Section 454(d) of the Local Government Code of 1991 requires that the appointments of heads of department and offices issued by the City Mayor shall be with the concurrence of the City Council;


WHEREAS, the confirmation of the appointment of Eddilyn De Chavez Dividina as City Government Department Head III of the Quezon City Youth Development Department will complete the substantive and procedural requirements set forth by the Civil Service Rules and Regulations regarding the nature of her appointment.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to confirm, as it does hereby confirm, the appointment issued by the City Mayor, Honorable Ma. Josefina G. Belmonte, to Eddilyn De Chavez Dividina as City Government Department Head III of the Quezon City Youth Development Department.


