A RESOLUTION DONATING ONE (1) UNIT OF SUZUKI APV UTILITY (EMERGENCY RESCUE VEHICLE) TO BARANGAY SOUTH TRIANGLE, DISTRICT IV, QUEZON CITY AND AUTHORIZING THE TRANSFER OF OWNERSHIP OF THE SAID VEHICLE TO THE RECIPIENT WITHOUT COST.

WHEREAS, the Barangay Local Government Unit is the keystone in maintaining peace and order, as well as first to respond in times of emergencies and calamities;

WHEREAS, to accelerate the delivery of public service by way of responding to emergency situations and to speed up its mobility as first responders, Barangay South Triangle needs an Emergency Rescue Vehicle. This vehicle will be utilized by the recipient-barangay in their emergency responses within their jurisdiction and for other various official emergency rescue services;

WHEREAS, considering the significant amount of funds that can be saved from payment of annual insurance coverage and renewal of registration, the City General Services Department recommended the transfer of the subject vehicle to the aforementioned Barangay Local Government Unit of Barangay South Triangle, through a Deed of Donation, without cost;

WHEREAS, to extend the aforementioned financial assistance, there is a need for the Quezon City Council to authorize the Honorable City Mayor to allocate and release funds for the same.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to donate, as it does hereby donate, one (1) unit of Suzuki APV Utility (Emergency Rescue Vehicle) to Barangay South Triangle, District IV, Quezon City and authorizing the transfer of ownership of the said vehicle to the recipient without cost.

RESOLVED FURTHER, that the ownership of the said vehicle be transferred to the recipients through a Deed of Donation, to be signed by the City Mayor, Honorable Ma. Josefina G. Belmonte and Councilor Ivy L. Lagman as the Donors and the Punong Barangay of the concerned barangay as the Donee, and the Head of the City General Services Department (CGSD).

RESOLVED FURTHERMORE, that the Barangay South Triangle be authorized to appropriate funds for the payment of the required insurance and registration fees of this donated vehicle.

RESOLVED FINALLY, that the copies of this Resolution along with the Deed of Donation be given to the recipient barangay, the Office of the City Mayor, the City General Services Department and the Office of Councilor Ivy Lagman for their records and references.
