RESOLUTION NO. SP-8973, S-2022

A RESOLUTION AMENDING RESOLUTION NO. SP-8659, ENTITLED "A RESOLUTION RENEWING THE SPECIAL PERMIT GRANTED TO BIG TIME GAMING CORPORATION TO OPERATE AN ELECTRONIC GAMES (E-GAMES) ESTABLISHMENT AT THE 2^{ND} FLOOR SIR THOMAS BUILDING, NO. 18 MATALINO STREET, BARANGAY CENTRAL, DISTRICT IV, QUEZON CITY, SUBJECT TO THE RULES AND REGULATIONS PROMULGATED BY THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR)", BY REPLACING IN THE WHEREAS CLAUSE WORDS "OPERATE AN ELECTRONIC GAMES (E-GAMES)" "OPERATE AN ELECTRONIC BINGO (E-BINGO) AND TRADITIONAL BINGO."

WHEREAS, Resolution No. SP-8659, S-2021 was approved by the City Council on July 27, 2021 and was confirmed on August 2, 2021;

WHEREAS, the owner of Big Time Gaming Corporation has requested the 21st City Council to replace in the whereas clause the words "operate an Electronic Games (E-Games)" to "operate an Electronic Bingo (E-Bingo) and Traditional Bingo";

WHEREAS, there is a need to replace in the whereas clause the nature of operation cited in the abovementioned resolution.
