RESOLUTION NO. SP- **8981**, S-2022

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO MARITES ONG FOR THE CONSTRUCTION OF A THREE (3)-STOREY STORAGE BUILDING WITH MEZZANINE AND OFFICE EMPLOYEES' QUARTERS AND PARKING (AS BUILT) LOCATED AT LOT 25, BLOCK 8, KING CHRISTOPHER STREET CORNER KING CHRISTIAN STREET, KINGSPPOINT SUBDIVISION, BARANGAY BAGBAG, DISTRICT V, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.

WHEREAS, Ms. Marites Ong is applying for the issuance of a Certificate of Exception for the construction of a Three (3)-Storey Storage Building with Mezzanine and Office Employees' Quarters and Parking (As Built) located at Lot 25, Block 8, King Christopher Street corner King Christian Street, Kingspoint Subdivision, Barangay Bagbag, District V, Quezon City, in accordance with the provisions of Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016;

WHEREAS, pursuant to the provisions of the aforesaid zoning ordinance, the construction of the proposed project may be allowed only upon authorization by the Quezon City Council;

WHEREAS, the proposed project will not adversely affect public health, safety and welfare, and is in keeping with the general pattern of development in the community;

WHEREAS, the purpose of securing a Certificate of Exception is to comply with the parking requirements and zoning classification of the said zoning ordinance;

WHEREAS, the Sangguniang Barangay concerned, as well as the homeowners or residents thereat, did not interpose any objection to the proposed project;

WHEREAS, the applicant has submitted the necessary and mandatory requirements in support of the proposed project and undertakes to comply with the provisions of existing laws, ordinances, and rules and regulations pertaining to public safety, environmental protection, and vehicular traffic.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Certificate of Exception to Marites Ong for the construction of a Three (3)-Storey Storage Building with Mezzanine and Office Employees' Quarters and Parking (As Built) located at Lot 25, Block 8, King Christopher Street corner King Christian Street, Kingspoint Subdivision, Barangay Bagbag, District V, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Comprehensive Zoning Ordinance of 2016.
