A RESOLUTION AMENDING RESOLUTION NO. SP-7820, S-2019, ENTITLED "A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO A-SHELL SERVICE STATION (SHELL GASOLINE STATION) FOR THE CONSTRUCTION AND OPERATION REFILLING STATION GASOLINE *LOCATED* AT**TIMOG** YBARDOLAZA, BARANGAY SACRED HEART, AVENUE, **OUEZON** CITY", BY CHANGING THE NAME OF PROJECT TO "MAPLETREE HOLDINGS, INC." AND TO COMPLETE THE ADDRESS OF THE PROJECT LOCATION TO NO. 93 TIMOG AVENUE CORNER SCOUT YBARDOLAZA STREET, BARANGAY SACRED HEART, DISTRICT IV, QUEZON CITY.

WHEREAS, the A-Shell Service Station (Shell Gasoline Station) has requested the 21st City Council to change the name of project to "Mapletree Holdings, Inc." and to complete the address of the project location to No. 93 Timog Avenue corner Scout Ybardolaza Street, Barangay Sacred Heart, District IV, Quezon City;

WHEREAS, there is a need to change the name of the project in the abovementioned resolution, appearing in all documents submitted, indicating the name of project as Mapletree Holdings, Inc. and to complete the address of the project location to 93 Timog Avenue corner Scout Ybardolaza Street, Barangay Sacred Heart, District IV, Quezon City.
