WHEREAS, he also held various positions in QCPD as the Chief of Intelligence and Investigation Branch, Police Station 5, District Operations Division, District Training Section, DPHRDD, District Headquarters Support Unit;

WHEREAS, he became the Chief of Academics Branch, Intelligence Training Group, Chief of Production Branch, Intelligence Division (N2), and Assistant Chief, Academics Branch, Intelligence Training Group of the Philippine National Police Headquarters in Camp Crame;

WHEREAS, he became the Chief of Police of Mabalacat City, Pampanga and Batangas City Police Station, Station Commander of Police Station 9 (Anonas), Deputy Regional Dir for Operations in MIMAROPA, Provincial Director and Chief of Regional Operations Division in Regional Police Office 8;

WHEREAS, it was worth noting that PBGen. Torre has earned nineteen (19) medals during his 4-year stint in Mindanao, four of which are for heroism (Medalyang Kadakilaan);

WHEREAS, as a gesture of welcome and support, it is appropriate for the City Government to extend warmest felicitations to PBGen. Torre for his incoming service to the city as the new QCPD District Director.
