A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ACQUIRE THROUGH NEGOTIATED SALE THE PARCEL OF LAND LOCATED AT ROQUE II, VISAYAS AVENUE EXTENSION, BARANGAY PASONG TAMO, QUEZON CITY, REGISTERED UNDER THE NAME OF HERMANO OIL MANUFACTURING AND SUGAR CORPORATION AND COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 004-2015012120 CONTAINING AN AREA OF MORE OR LESS ONE THOUSAND THREE HUNDRED THIRTY (1,330) SQUARE METERS, INTENDED AS PERMANENT ROAD RIGHT-OF-WAY FOR THE RESIDENTS OF ROQUE II, BARANGAY PASONG TAMO, QUEZON CITY.

WHEREAS, Hermano Oil Manufacturing and Sugar Corporation is the registered owner of a parcel of land located at Roque II, Visayas Avenue Extension, Barangay Pasong Tamo, Quezon City, covered by Transfer Certificate of Title No. 004-2015012120 and containing an area of more or less one thousand three hundred thirty (1,330) square meters intended to be used as road right-of-way;

WHEREAS, the Sangguniang Barangay of Pasong Tamo, Quezon City, passed and approved Resolution No. 14-026, S-2014, requesting the Quezon City Government through the City Mayor to approve, negotiate, implement and provide funds for the purchase of the aforesaid property to be used and utilized as permanent road right-of-way of Roque II, Barangay Pasong Tamo, Quezon City;

WHEREAS, Hermano Oil Manufacturing and Sugar Corporation has expressed its willingness to sell the subject property to the Quezon City Government at a negotiated price subject to the terms and conditions of the government procurement process;

WHEREAS, the only existing road right-of-way being utilized by the residents of Roque II, as ingress and egress is a private road within San Pedro V Subdivision, resulting to limited and restricted access thereto;

WHEREAS, San Pedro V Subdivision has long ago manifested its strong desire to close the said private road in the interest of security and privacy;

WHEREAS, the residents of Roque II have identified an alternative road right-of-way near the Visayas Avenue Extension passing through the portion of the property of Hermano Oil Manufacturing and Sugar Corporation approximately 1,330 square meters as drawn and indicated in the drawing hereto attached and made an integral part hereof;

WHEREAS, the purpose of acquiring the above-cited properties is to be utilized and used as permanent road right-of-way for the residents of Roque II, Barangay Pasong Tamo, Quezon City;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.
