A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO SIGN THE DEED OF DONATION IN FAVOR OF THE MUNICIPALITY OF RODRIGUEZ, PROVINCE OF RIZAL, REPRESENTED BY ITS MUNICIPAL MAYOR LT. GEN. RONNIE EVANGELISTA (Ret.), FOR THE DONATION OF THIRTY-TWO (32) PARCELS OF LAND CLASSIFIED AS ROAD LOTS, ALLEYS, AND OPEN SPACES LOCATED IN SITIO MAISLAP, BARANGAY SAN ISIDRO, RODRIGUEZ, RIZAL.

WHEREAS, the thirty-two (32) lots are classified as road lots, alleys, and open spaces which are part of the off-city resettlement site of the Quezon City Local Government;

WHEREAS, as an act of generosity and to further give the Quezon City relocatees access to public services, the Quezon City Government transfers, and conveys full ownership of the above-mentioned parcels of lands, by way of donation, to the Municipality of Rodriguez, Province of Rizal;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to sign the Deed of Donation in favor of the Municipality of Rodriguez, Province of Rizal, represented by its Municipal Mayor Lt. Gen. Ronnie Evangelista (Ret.), for the donation of thirty-two (32) parcels of land classified as road lots, alleys, and open spaces located in Sitio Maislap, Barangay San Isidro, Rodriguez, Rizal.

RESOLVED FURTHER, that a copy of the subject Deed of Donation be made an integral part of this Resolution.
