A RESOLUTION CREATING A TECHNICAL WORKING GROUP (TWG) TO CONSOLIDATE AND CODIFY ALL QUEZON CITY ORDINANCES AND RESOLUTIONS RELATING TO THE WELFARE, BENEFITS, AND PRIVILEGES OF SENIOR CITIZENS IN QUEZON CITY.

WHEREAS, it is the policy of the Quezon City Government to establish mechanisms whereby the contributions of the senior citizens are maximized, and to adopt measures whereby our senior citizens are assisted and appreciated by the community as a whole;

WHEREAS, in view of this mandate, the Quezon City Government has adopted numerous legislative measures in achieving its goal. Thus, there is an imperative need to codify all these ordinances and resolutions for easy and ready reference;

WHEREAS, Senior Citizens belong to a special sector that needs singular attention to promote the social, economic and spiritual aspects of their lives, as well as allow them to convey their special concern;

WHEREAS, Section 458, Paragraph (5)(XVII), Article III of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Panlungsod shall approve ordinance which shall ensure the efficient and effective delivery of basic services and facilities and in addition shall, formulate policies and adopt measure mutually beneficial to the elderly and to the community, provide incentives for non-governmental agencies and entities and, subject to the availability of funds, appropriate funds to support programs and projects for the benefit of the Senior Citizens.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to create, as it does hereby create, a Technical Working Group (TWG) to consolidate and codify all Quezon City Ordinances and Resolutions relating to the welfare, benefits, and privileges of senior citizens in Quezon City.

RESOLVED FURTHER, that the Technical Working Group (TWG) shall be composed of the following, to wit:
