BELMONTE, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE INTENDED FOR THE MONITORING AND IMPLEMENTATION OF THE PROJECTS AND PROGRAMS OF THE GENDER AND DEVELOPMENT (GAD) COUNCIL, GAD TECHNICAL WORKING GROUP AND GAD SECRETARIAT, TO BE CHARGED AGAINST THE AVAILABLE FUNDS OF THE CITY.

WHEREAS, Quezon City Ordinance No. SP-1402, S-2016 provides for the creation of the Gender and Development Council, GAD Technical Working Group and the GAD Secretariat, to ensure the effective and efficient implementation of the GAD programs and activities;

WHEREAS, there is a need to purchase a one (1) unit of motor vehicle to be used for the monitoring and implementation of its projects and programs, with the following specification:


