A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO GLOBAL BUSINESS TOWER DEVELOPED BY ASUKI DEVELOPMENT AND CONSTRUCTION MANAGEMENT, INC. OWNED BY RT AND HM UNITY CORPORATION FOR THE CONSTRUCTION OF ADDITIONAL TWO (2) FLOORS (AS BUILT) FROM THE APPROVED EXCEPTIONS OF EIGHTEEN (18)-STOREY OFFICE/WAREHOUSE WITH MEZZANINE TO BE LOCATED AT LOT 1, BLOCK 42, N. DOMINGO STREET CORNER MAYOR IGNACIO DIAZ SANTOS STREET (FORMERLY BANAHAW STREET), BARANGAY KAUNLARAN, DISTRICT IV, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE OF 2016.

*WHEREAS, Global Business Tower developed by Asuki Development and Construction Management Inc. owned by RT and HM Unity Corporation is applying for the issuance of a Certificate of Exception for the construction of Additional Two (2) Floors (As Built) from the approved exception of Eighteen (18)-Storey Office/Warehouse with Mezzanine to be located at Lot 1, Block 42, N. Domingo Street corner Mayor Ignacio Diaz Santos Street (formerly Banahaw Street), Barangay Kaunlaran, District IV, Quezon City;*

*WHEREAS, pursuant to Paragraph 2, Section 55, Article VIII of Ordinance No. SP-2502, S-2016 an Exception is required for the aforesaid project upon authorization from the City Council;*


WHEREAS, the applicant has complied with the necessary requirements prescribed by law, ordinance or administrative issuances in its application for the construction of the additional two (2) floors;


NOW, THEREFORE,

Domingo Street corner Mayor Ignacio Diaz Santos Street (formerly Banahaw Street), Barangay Kaunlaran, District IV, Quezon City, allowing deviation from the restrictions provided under Ordinance No. SP-2502, S-2016, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2016.
