RESOLUTION NO. SP- 9093, S-2022

A RESOLUTION COMMENDING FORMER QUEZON CITY POLICE DISTRICT (QCPD) DIRECTOR, POLICE BRIGADIER GENERAL REMUS MEDINA, FOR HIS OUTSTANDING AND QUICK RESPONSE LEADING TO THE IMMEDIATE ARREST OF THE ASSAILANT IN THE PERSON OF DR. CHAO TIAO YUMOL, ON THE SHOOTING INCIDENT INSIDE THE CAMPUS OF ATENEO DE MANILA UNIVERSITY, WHICH CLAIMED THE LIVES OF THREE INDIVIDUALS AND INJURED TWO OTHERS.

WHEREAS, the graduation ceremony of Ateneo Law School held on July 24, 2022, which was supposed to be a solemn and joyful event turned into a day of bloodshed when a man opened fire around an hour before said ceremony, killing three people and injuring two other individuals;

WHEREAS, the incident led to the death of three individuals - former Basilan Mayor Rose Furigay, her long-time aide Victor George Capistrano, and Ateneo security guard Guidon Jeneven Bandiala. The former Mayor and Bandiala were declared dead on arrival in separate hospitals, while Capistrano died at the scene of the crime;

WHEREAS, the footage released by the news shows authorities in front of the Saint Joseph Shrine along Aurora Boulevard, near the Anonas LRT Station, flagging down a UV bus that the suspect was riding in. Police recovered two guns from Yumol, the latter admitting to have used the one with a silencer in committing the crime;

WHEREAS, then Quezon City Police District Director, Police Brigadier General Remus Medina, wasted no time in responding to the incident. As a result of his prompt action, the suspect, wounded in a shootout with a campus security officer, was arrested after a car chase;

WHEREAS, it is just and proper to give the sincerest congratulations and commendation to former Quezon City Police District Director, Police Brigadier General Remus Medina, for his outstanding leadership and immediate action and response to the incident which led to the arrest of the perpetrator.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to commend, as it does hereby commend, former Quezon City Police District (QCPD) Director, Police Brigadier General Remus Medina, for his outstanding and quick response leading to the immediate arrest of the assailant in the person of Dr. Chao Tiao Yumol, in the shooting incident inside the campus of Ateneo De Manila University, which claimed the lives of three individuals and injured two others.

RESOLVED FURTHER, to furnish copies of this Resolution to Police Brigadier General Remus Medina for his information and as a memento of his remarkable achievement.
