A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE J. AMADO ARANETA FOUNDATION, INC., (JAAF) ON THE PROVISION OF A FOUR (4)-YEAR FINANCIAL EDUCATION ASSISTANCE TO SELECT PUBLIC SENIOR HIGH SCHOOL GRADUATES.

WHEREAS, Section 1, Article XIV of the 1987 Philippine Constitution provides that "The State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all";

WHEREAS, the Quezon City Government and the J. Amado Araneta Foundation (JAAF), the social development arm of the Araneta Group, recognizes that private-public partnership is essential in pursuing corporate sustainability especially in the area of education;

WHEREAS, the JAAF aims to confer the J. Amado Araneta Student Excellence Award and Scholarship to the Top public school graduating students in recognition of their exemplary work, dedication and ingenuity which personifies the life and legacy of Don Amado Araneta;

WHEREAS, the scholarship is a 4-year financial educational assistance in the amount of Twenty Thousand Pesos (Php20,000.00) per school year per awardee and can be used for educational needs such as supplies, tuition and other fees, dormitory, transportation, daily living allowance, and as the awardee may deem fit;

WHEREAS, the primary role of the City Government under the partnership is to provide the necessary information and support for the design, administration and implementation, and evaluation of the program;

WHEREAS, both parties endeavor to support and promote each other's policies and programs pursuant to the objectives set out in the Memorandum of Agreement;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Memorandum of Agreement with the J. Amado Araneta Foundation, Inc., (AAF) on the provision of a four (4)-year Financial Education Assistance to select public senior high school graduates.
