RESOLUTION NO. SP- 9.119 , S-2022

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO MARK ANSON TAN YUPITUN FOR THE CONSTRUCTION AND OPERATION OF A FIFTEEN (15) WAREHOUSES WITH OFFICE BUILDING TO BE LOCATED AT NO. 44 DAMONG MALIIT, BARANGAY NAGKAISANG NAYON, DISTRICT V, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS PROVIDED UNDER ORDINANCE NO. SP-2502, S-2016, OTHERWISE KNOWN AS THE COMPREHENSIVE ZONING ORDINANCE OF 2016.
