*WHEREAS, New Era University is a duly authorized academic institution, organized and existing under and by virtue of Philippine laws, with principal place of business at No. 9 Central Avenue, New Era, Quezon City and represented by its University President, Dr. Nilo L. Rosas, CESO I Edd;*

WHEREAS, New Era University proposes to the Quezon City Health Department to allow the affiliation and training of its Nursing Students duly enrolled at the New Era University College of Nursing;

WHEREAS, the Quezon City Health Department agrees to affiliate and train the Nursing Students of New Era University College of Nursing to be deployed to the Quezon City Health Department, the various Health Centers and Lying-in Clinics managed by the Quezon City Government;

WHEREAS, the Quezon City Government shall not be responsible for the NEU Students medical expenses and/or hospitalization in case of any physical injuries or illness of the student that occurred during the conduct of training or field activities, or for any other injuries or a result of action arising from the fault of parties to the service of learning activity;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into a Contract of Affiliation with the New Era University, represented by its University President, Dr. Nilo L. Rosas, CESO I EdD, for the affiliation and training of the Nursing Students of the New Era University College of Nursing to the Quezon City Health Department.

RESOLVED FURTHER, that a copy of the subject Contract of Affiliation shall form an integral part of this Resolution.


